- a) According to the House Rules, AHWP representatives from regulatory authorities can be nominees in the AHWP Chair and AHWP Vice-Chair (Regulatory Authority) elections. AHWP representatives from the Industry can be nominees in the AHWP Vice-Chair (Industry) election.
- b) Each supporter in Part 3 of this nomination form can only support one nominee for each of the position as stated in Part 1 of this nomination form. According to the House Rules, supporter from the same member economy of the nominee is NOT accepted.
- c) Only the submission of nomination with i) <u>completely filled form, ii) email proof of support from each of the supporter in Part 3 of this form and iii) a brief CV (maximum 2 pages in A4 size paper) of the nominee will be processed. The submission should reach the AHWP Secretariat at "secretariat@ahwp.info" <u>on or before 23:59pm (GMT+8), 28 October 2011</u>. Any late submission will not be accepted.</u>
- d) The AHWP Chair has the full authority to review the voting rights and validity of the nominee and the supporters as stated in this form, and to reject any application that cannot fulfill the requirements as stated in the Terms of Reference and House Rules of AHWP, and the instructions as stated in this nomination form.
