# Financial Position and Arrangement

- HK\$660,073.11 (US\$84,624.76) from AHWP Reserve/Fund managed under the Hong Kong Productive council (HKPC) was transferred to ASL bank account on 14 Sep 2011.
- First Treasurer and/or First Vice-Treasurer would propose payment recommendations to the Board of ASL for endorsement before each of the payment transaction.
- It will be the Board level's decision with the agreement by at least Three Board of Directors to endorse any proposed payment.
